Welcome to the first edition of *ACE Info* in 2011, in which you will discover a number of items of both general and specific interest as they relate to the priorities and actions of the European Institutions in the fields of architecture and the built environment.

An eventful year lies ahead for the ACE as the European Union progresses with its policy plans in several key areas for the architectural profession. First amongst these is the intention to modernise the Directive on the Recognition of Professional Qualifications (2005/36/EC) under whose provisions the architects of the EU enjoy automatic recognition of their qualifications when they migrate within the borders of the EU. For the architectural profession, this action of the Commission provides the opportunity to advocate for a change in the text of the Directive so as to bring its provisions into line with common educational practices across the EU.

The key objective of the ACE is to ensure that the text will be modified (in Article 46) to require that the minimum duration of studies for architects be stated as being five years. In addition, the ACE will have the opportunity to ensure that when Member States notify the European Commission of the qualifications they recognise at national level, these notifications contain the provisions relating to the acquisition of professional practice experience as well – qualifications usually acquired after formal education in a third level institution.

These two changes are crucial for a number of reasons. Firstly, well over 95% of all courses of architecture that lead to a recognised qualification are already of five years duration. The mention in the current Directive of a minimum duration of four years is an anachronistic remnant of the negotiations that led to the adoption of the Architects' Directive in 1985 and should be revised. Secondly, at global level, the profession has adopted International Standards of professionalism in architecture in which the minimum duration of studies is stated as being five years. This current discrepancy makes it difficult for the ACE to negotiate international agreements with the countries that the EU has Free Trade Agreements with, as it gives a false impression that the EU standard for education falls short of the global standard.

The General Assembly of the ACE has agreed, in December 2010, that the top priority for the 2011 has to be the work related to the modernisation of the Directive on the Recognition of Professional Qualifications and our work on the issues is already underway.

Another related work in 2011 and on the same subject, is collaboration of the ACE with the Schools of Architecture in the EU as notifications of diplomas under the Directive on the Recognition of Professional Qualifications must start with them. Unfortunately, it seems that in many countries the schools and universities appear to be unaware of their important role in ensuring that graduates of their courses can enjoy automatic recognition of their qualifications when they move within the borders of the EU.

The other key priority issues that the ACE will need to address include the review of the Directive on Public Procurement (a public consultation has just been launched – see item in this edition) as well as the adoption of the revised Energy Efficiency Strategy (due in March 2011).

### Public Consultations Open on Key Directives



The European Commission has recently launched two Public Consultations on key Directives that affect the architectural profession. The first, with a deadline for responses of the 15<sup>th</sup> March 2011, relates to the Directive on the Recognition of Professional Qualifications (2005/36/EC). As discussed in the editorial above, the ACE considers the modernisation of this Directive to be its top priority for 2011. To view the

The second important consultation, with a deadline of 18<sup>th</sup> April 2011, relates to the review of the European procurement market and includes a review of the Framework Directive on Public Procurement of Services and Works (2004/18/EC) that is of particular concern to the architectural profession. This Directive has been transposed into the national laws of the Member States of the EU in such a way that the opportunities for architects to win public contracts has been severely restricted – exactly the opposition of the objective of the legislation. ### ACE Survey Indicates Double Dip Recession is Underway



The result of the latest survey by the ACE on the impact of the global financial and economic crisis on the architectural profession indicates that a double dip recession is underway in Europe. When linked to recent statements by the EU Employment Commissioner, Laszlo Andor, that the EU is experiencing a “jobless recovery”, the prospects for 2011 for architects seem bleak. In fact the level of optimism about the future workload for the profession has dropped significantly since the last running of the survey in June 2010 and the expectation of an increase in staff numbers in architects’ offices is also low.

Statements by Commissioner Andor came during comments on a recent report by the International Labour Organisation that shows that developed countries and regions (the EU, Australia, Canada, Japan and the USA) have suffered much larger increases in unemployment than other parts of the world. In the EU, the most worrying aspect of the recent figures is the fact that young people (those under 25 years of age) are the worst affected by these increases in unemployment. For example, in Spain where the overall unemployment level is running at over 20%, roughly 43% of those under 25 are unemployed. This pattern is repeated in many EU countries. Given that young people are the future, it is imperative that rigorous action is undertaken to re-dress this situation and, for architects, it is necessary to ensure that we do not have a “lost generation” of recent graduates. ### **Procurement – The ACE General Assembly Adopts Two Important Documents**

At its Second General Assembly in 2010, the ACE adopted two key documents related to the issue of public procurement. The first was a draft position paper on the review of the Public Procurement Directive (2004/18/EC) and was the result of hard work in the ACE Work Group on the subject, which had met in October 2010. It recalls the difficulties that the architectural faces in relation to the procedures used by contracting authorities across the EU and it outlines the principles that should be put in place to rectify the situation. The second paper adopted is the Master Document on Architectural Design Contests. It is the fruit of long and careful work led by Executive Board member, Georg Pendl of Austria and of the nominated experts of many member organisations of the ACE. It sets out all of the stages that must be followed by a contracting authority when using architectural design contests to procure the services of an architect and it relates the stages of a contest to the various Articles in the EU Directive on Public Procurement, thereby giving clear and reliable guidance to any users of the document. It is hoped that it will become the principal reference for all contracting authorities across the EU and readers of *ACE Info* are invited to promote its use as widely as possible. ### **Action Plan for the Danube Region Announced**

The President of the European Commission, José Manuel Barroso, announced the main priorities for an EU Action Plan for the Danube Region in November 2010. The long-term strategy will involve eight Member States and six other countries and will create the second *macro-region* in the EU. The first was created by the EU Strategy for the Baltic Sea Region in 2009. There are four main axes in the Strategy: develop the Danube as a freight corridor, improve the quality of the environment, stimulate economic development and improve security and movement of persons and goods. Although there is no specific funding associated with the Strategy, it will facilitate the planning and coordination of national and European investments throughout the region. The architects in the countries covered by the Strategy are optimistic that there will be direct benefits for them in terms of new, sustainably conceived development along the Danube corridor.

A major study will shortly be initiated that will seek to identify and analyse the barriers that prevent people with disabilities from making full use of public buildings, transport and all kinds of services. ### Green Homes Don't Translate to Sales Success

Results from new EU-funded research show that home buyers are unwilling to buy new, energy-efficient houses. Poor communication between builders and buyers is a big part of the problem.
